Please see an email trail below concerning a proposal from Townsville City Council to DPC regarding a proposed visit to Boston (USA) by the Premier in late May and the signing of a Heads of Agreement between Boston Energy and Innovation/Imperium 3, Townsville City Council and QG to progress a Feasibility Study into the proposed Lithium Ion Battery Plant in Townsville. DSDMIP were made aware of this yesterday.

The QG has committed \$3.1 million during the election to part fund the feasibility study (\$12million) into the plant. The Townsville City Council has provided some land for the project in an equity swap arrangement. The \$3.1 million will be made available under the Jobs and Regional Growth Fund. A term sheet has been developed by DSDMIP and a meeting to discuss the term sheet was to be held tomorrow but has been delayed until next week at the request of Imperium 3. Agreement on the term sheet and conditions of the funding has not been reached between DSDMIP and Imperium 3. It should be noted that the agreement of the Term sheet is between QG and Imperium 3. Townsville City Council is not a party to this Term Sheet.

The signing of a heads of agreement could be construed that the Qld Government has committed to supporting the project beyond the funding outlined in the election commitment. If the signing of a Heads of Agreement were to progress, we would advise that the wording of the agreement limit the QG to supporting the feasibility assessment only rather than a broader statement of support. The Term Sheet being proposed for Imperium 3, contains clauses that will allow the QG to utilise some of the IP developed in the feasibility assessment to progress other Battery manufacturing opportunities in Queensland, should the Imperium 3 proposal not proceed. DSDMIP MPP is also briefing the Minister on the broader EOI process being undertaken on the potential for a Lithium Ion Battery processing industry in Qld

Please note that Gerard is briefing Toni Power on this issue also and Michael Allen has been asked to brief the Minister on the impacts of the Imperium 3 proposal on the broader EOI. I'm raising this with you as an FYI and that we may need to have a united approach to DPC on how this Heads of Agreement is developed if a meeting proceeds.
