Description of the land

Real property description: Lot 29 on RW89, Lot 30 and 31 on RW90, Lot 9 on RW431, Lot 44 on RW90 and Lot 45 on RW85

Area of regional interest: Wide Bay Burnett Strategic Environmental Area (WBB SEA)

Local Government Area: North Burnett Regional Council

Approved resource activities

Access tracks	<ul style="list-style-type: none">Construction of three, 4.0m wide drill line access tracks.Use of existing station tracks to gain access to the exploration areas.Blade-up track construction to minimise disturbance to topsoil.Rehabilitated once exploration concludes.

Drill lines	<ul style="list-style-type: none"> • Exploration drilling will be undertaken wholly within drill lines to minimise the level of overall disturbance and disturbance to environmental attributes. • Vegetation clearing and minor earthworks may be required to prepare drill lines and will be by blade up method to minimise disturbance to roots and topsoil. • Drilling will be undertaken using air core drilling methods to a depth of up to 30m which will be conducted by a qualified and experienced contractor. • Drilling equipment is likely to include the drill rig (3 or 4 axle body truck), a support truck (3 or 4 axle body truck) and 4WD utilities. • Rehabilitated once exploration concludes.

2.	Access tracks should be co-located as much as practically possible.	At all times
