Directly Impacted Properties

This appendix details the properties and interests traversed by the permanent operational and temporary construction disturbance footprints for the Helidon to Calvert Project (the Project).

Project definitions of relevance to this appendix are as follows:

- ▶ **Permanent operational disturbance footprint:** The land required to encompass permanent infrastructure components as associated with operation of the Project. This includes the rail corridor, access tracks, signalling infrastructure, bridge maintenance infrastructure and other the like.
- ▶ **Temporary construction disturbance footprint:** The area that would be directly affected by construction works (also known as the construction footprint). It includes the location of proposal infrastructure, the area that would be directly disturbed by the movement of construction plant and machinery, and the location of the storage areas/compounds sites and the like, that would be used to construct that infrastructure. These areas would be rehabilitated prior to operation.

Methodology

In identifying properties and interests and calculating areas traversed by the permanent operational and temporary construction footprints, geographic information system calculations referenced the spatial datasets detailed in Table G.1.

Dataset name	Datatype
Queensland Digital Cadastral Database (DCDB) (Queensland Government, 2019)	The DCDB contains the property boundaries and related property description of all land parcels in Queensland.
Queensland Land Use Mapping Program (QLUMP) (Queensland Government, 2019)	The QLUMP dataset is digital map of the most recent land use of Queensland. Land use is classified according to the Australian Land Use and Management Classification.

When identifying the predominant land use of the impacted properties as mapped by QLUMP, multiple land uses may be mapped within the one allotment. In such instances, the land use which takes up most of the land within the footprint has been included for the purposes of the impacted properties list.

Impacted properties

Between Helidon and Calvert, the permanent operational disturbance footprint traverses 193 properties and 36 easements. The temporary construction disturbance footprint, which also covers the permanent operational disturbance footprint, traverses 341 properties and 37 easements.

The extent of area associated with these properties within the permanent operational and temporary construction disturbance footprints, as well as tenure and existing land uses of these properties, are provided in Table G.2.
