Re: Queensland Curtis LNG conditions relating to CSG Industry Monitoring Group

Thank you for the continued effort your department is making to ensure our conditions remain relevant and meaningful for the project and the communities in which we operate.

As per my team's discussions with officers from your department, Queensland Curtis LNG (QCLNG) seeks to progress a change request in relation to Appendix 1, Part 1 Condition – CSG Industry Monitoring Groups.

QCLNG is committed to the intended outcomes of the CIMG, in relation to monitoring cumulative impacts. While the CIMG has not yet been established, QCLNG is already participating with other proponents in industry research and monitoring groups:

1. University of Queensland Centre for Coal Seam Gas (CCSG)

The Centre for Coal Seam Gas (CCSG) was established at The University of Queensland in 2011 with the support of industry partners QGC, Arrow Energy and Santos. CCSG aims to provide a single coordinated access point for industry and government to address challenges presented by gas industry development.

CCSG projects include a study on the cumulative socioeconomic impacts of coal seam gas activity in the Western Downs and a research initiative on the interaction of coal seam gas development with agriculture activity. More information is available at www.ccsg.uq.edu.au.

2. Gas Industry Social and Environmental Research Alliance (GISERA)

QCLNG has recently contributed funding and actively participates as a member of GISERA which is taking a multi-proponent approach to research cumulative impacts of the Queensland CSG industry. Specific research areas include surface and groundwater, agricultural land management, terrestrial biodiversity, marine environment and socio-economic impacts and opportunities.
