Thank you for your email and your request seeking Councils advice in relation to BCC Communications conduits as part of the upgrade of Remora/MacArthur intersection in Northshore Hamilton PDA.

Upon review of the submitted layout and intersection plans for the above mentioned road upgrade propose work.

We are pleased to inform you the below advice we have received from our Duct & Fibre Management team.

"In addition to the usual ducts around traffic signal intersections, Council requires two x 100mm orange PVC ducts from Kingsford Smith Drive to the Remora/MacArthur intersection and then to continue to the Finnegan/MacArthur intersection.

These ducts must come from nearest "new" BCC pit in Kingsford Smith Drive and go to P8 pits (with lids designated as "Traffic Signals") adjacent to each traffic signal controller. Additional pits on these ducts are required near each side street and in the middle of spans, if the span exceeds 100 metres.

Elsewhere a 1×100 mm orange PVC duct shall be installed on one side of other streets where the street is being constructed, re-aligned or widened. These ducts are for future optic fibre services, smart city devices and CCTV and need to connect to pits in Kingsford Smith Drive and, where applicable, to the intersection traffic signal ducts. Intermediate P4 pits are required at intervals no greater than 50 metres."

In addition to above feedback, we have also requested advice from few of the other relevant internal stakeholders.

Below is an update on uncontrolled vehicular access to the Hamilton Recreation Reserve following our meeting last week and a request regarding BCC communications conduits.

Hamilton recreation Reserve

We met with Lendlese this week and agreed on the following actions in relation to the uncontrolled vehicular access to the Hamilton Recreation Reserve:

- BMD will salvage the existing lock rail at the south of the park and provide to Lendlease; and
- Lendlease will install the salvaged lock rail and install fencing either side of the installed rail to restrict vehicular access into the park.

BCC Communications Conduits

The current design for the Remora MacArthur upgrade does not include dedicated BCC communications conduits. We understand that this is not a requirement for this project as it is not related to a sub-division, which is why it is currently included in the scope of the project.

Given the communication conduits are typically something that BCC does install and the fact that the footpath treatments for the project are largely high quality concrete for most of the verge width, we would prefer to see those conduits installed now rather than later.

Can you provide details of where BCC would install the communications conduits in the future, the size and number of conduits and the offset from the boundary for the conduits? We are currently trenching for service relocations and

would like to install any BCC communications conduits during these operations so if you are able a quick response that would be appreciated.

EDQ have advised that these latest set of plans now take into consideration BCC comments, Road Safety Audit comments, Peer Review comments and coordination with tie-ins to the KSD works.

From Councils point of view, we still have many fundamental issues outstanding which have yet to be adequately addressed by EDQ. Additionally we have yet to be convinced that the advice given by their own peer reviewers has been taken seriously and on board or even adequately been addressed in relation to the planning and design of this very important intersection and how it will perform and be aligned with the rest of the network. Council will likely have ongoing issues with further road network designs.

As we have followed a lengthy and thorough review process for above upgraded design works, and we continue to hit brick walls and yet be in a position to achieve an agreed resolution, It is been agreed by both parties (BCC and EDQ) to escalate these matters to the Technical Working Group (TWG) and request that the Steering Group step review the findings and provide a resolution as part of the agreed Memorandum of Understanding currently in place.

Please note that we are providing this information to you, not as a requirement to provide your feedback but to ensure you have access to their latest design plans for your information should you see a benefit in looking over the so called updated changes taking into consideration BCC comments and the Road Safety Audit comments.
