The Development Scheme, Guideline and DCOP enable significant community benefits, including:

- the expansion of knowledge-intensive activities, stimulating growth in innovation and jobs in health, science and education services
- improved amenity and precinct activation
- a network of high-quality open space including a family-focussed Outlook Park, new urban common in the Princess Alexandra precinct, significantly enhanced Boggo Road Gaol park and new public plaza adjacent to the new Boggo Road station
- a system of new and upgraded pedestrian and cycle links to make active transport safer, quicker and more efficient
- the adaptive re-use of the Boggo Road Gaol for community use purposes.

The approval of these documents represents a major milestone, establishing the principal policy platforms to guide and assess the transformational redevelopment of the PDA.

RECOMMENDATION

It is recommended that you:

- approve the making of the new ILUP (dated November 2022) for the Woolloongabba CRR PDA (Attachment 1)
- sign the letter to Mr Graeme Newton, Chief Executive Officer (CEO), Cross River Rail Delivery Authority (CRRDA) (Attachment 2)
- sign the letter to Mr Colin Jensen, CEO, Brisbane City Council (Attachment 3)
- note that, subject to your approval of the new ILUP (dated November 2022), a notice specifying the
 effective date as 24 November 2022 will be published in the Queensland Government Gazette on
 18 November 2022.

BACKGROUND

- On 3 April 2020, the Woolloongabba CRR PDA was declared, and an ILUP (dated April 2020) was given
 effect, to provide an interim regulatory planning framework for period of 18 months whilst a development
 scheme is prepared.
- Following declaration of the Woolloongabba CRR PDA, the CRRDA, as the then delegate of the Minister for Economic Development Queensland (MEDQ), commenced preparation of the development scheme as the long-term regulatory planning instrument.
- On 19 July 2021, following a request from the CRRDA, you approved the Department of State
 Development, Infrastructure, Local Government and Planning's recommendation that the ILUP for the
 Woolloongabba CRR PDA would need to be re-made. This was approved on the basis that additional
 planning would be required to respond to a potential successful 2032 Olympic and Paralympic Games
 hosting bid, and that a decision regarding this would be made following the decision of the International
 Olympic Committee (IOC).
- On 21 July 2021, the IOC selected Queensland as host of the Brisbane 2032 Olympic and Paralympic Games (Brisbane 2032).
- On 15 November 2021, you approved a new ILUP (dated November 2021) for the Woolloongabba CRR PDA, which took effect on 24 November 2021, providing up to 12 months for additional planning to be undertaken in response to the IOC's decision, and the State Government's announcement about the Gabba Stadium redevelopment.

- In addition to providing an additional 12 months for development scheme preparation, the new ILUP (dated November 2021) included several amendments when compared against the original ILUP (dated April 2020) including:
 - 1. updates to section 1.3 Application of the ILUP and Planning for Games to acknowledge the need for additional planning to be undertaken
 - 2. insertion of a new section 2.1.2 2032 Olympic and Paralympic Games and updates to section 2.1.6 Focus of the Woolloongabba CRR PDA to acknowledge Brisbane's successful 2032 Olympic and Paralympic Games hosting bid and how the Gabba Stadium redevelopment relates to the broader PDA
 - 3. updates to Section 2.2 Vision to state that the PDA will capitalise on the opportunities presented by Brisbane 2032
 - 4. updates to embed provisions relevant to two election commitments, being:
 - a) minimum 50 per cent open space provision (GEC1645)
 - b) affordable and social housing requirements GEC1646).
 - 5. updates to precinct boundaries resulting in all government land holdings being contained within Precinct 2.
- Planning is not yet finalised for the Woolloongabba CRR PDA, and the ILUP (dated November 2021) is due
 to expire on 24 November 2022. Consequently, approval of a second new ILUP is required to facilitate
 additional planning, followed by development scheme preparation including public notification.
- There are no provisions under the Economic Development Act 2012 to 'extend' an existing ILUP. However, section 40AC provides for you, as the MEDQ, to make a new ILUP for a maximum effective period of up to 12 months.
- Subject to your approval, the enclosed new LUP (dated November 2022) will provide up to 12 additional
 months for finalisation of the development scheme on or before 24 November 2023.

KEY ISSUES

- The Gabba Stadium is planned to be redeveloped and will be the venue for Brisbane 2032's athletics, as well as the opening and closing ceremonies.
- The planning, staging, design and delivery of Olympics infrastructure, including the Gabba Stadium redevelopment, is not yet complete. A master planning exercise, led by Economic Development Queensland (EDQ), addressing these considerations is currently being undertaken, with the outputs of this to inform the policy settings in the forthcoming development scheme. This work requires collaboration with relevant state agencies and bodies responsible for coordinating the delivery of the Brisbane 2032, including the Organising Committee.
- The making of a new ILUP is not subject to public notification. Accordingly, when compared against the current ILUP (dated November 2021), the new ILUP (dated November 2022) includes only minimal updates. These relate to the date of the new ILUP and minor amendments to section 1.3 Application of the ILUP and Planning for Games, which describes the relationship between the new ILUP (dated November 2022) and Brisbane 2032, as well as acknowledging the need for additional planning.
- The new ILUP (dated November 2022) will expire 12 months after it takes effect unless a development scheme is finalised prior.
- The new ILUP (dated November 2022) will take effect on the expiry of the current ILUP (dated November 2021). Subject to your approval, a notice specifying the effective date for the new ILUP (dated November 2022) will be published in the Queensland Government Gazette on 18 November 2022.

RESULTS OF CONSULTATION

 Internal consultation with EDQ's Planning and Urban Design team has been undertaken, and all agree on the content of the new ILUP (dated November 2022).

RESOURCE/FINANCIAL IMPLICATIONS

• There are no resource (e.g. staffing) or financial implications associated with this briefing note.

SENSITIVITIES/RISKS

- Should the current ILUP (dated November 2021) expire without provision for a second new ILUP, there would be no interim regulatory planning framework for the Woolloongabba CRR PDA.
- Dr Amy MacMahon MP, Member for South Brisbane, has previously asked you a Question on Notice (No. 983) about whether the State Government had abandoned its commitment to deliver 50 per cent 'public parkland' in the Woolloongabba CRR PDA. Dr MacMahon has also raised this matter through social media.

ELECTION COMMITMENTS

- There are two election commitments relevant to the Woolloongabba CRR precinct, being:
 - 1. 'make 50 per cent of the Woolloongabba CRR precinct into open space co-designed with the community' (GEC1645)
 - 2. 'include affordable housing for nurses, teachers and other frontline workers, as well as social housing in the future design of the Woolloongabba CRR precinct' (GEC1646).

- note that on 7 July 2022, Mr Graeme Newton, wrote to you as delegate of the Minister for Economic Development Queensland (MEDQ) requesting your endorsement of the scheme, submissions report, DCOP and Kent Street guideline
- note that the approved scheme, submissions report, DCOP and Kent Street guideline will be published on DSDILGP's website
- note that you considered state interests relevant to the scheme prior to approving the proposed scheme for public notification and that changes made in response to submissions do not affect this consideration

 functions and powers for the CRR PDAs under the existing instrument of delegation to the Chief Executive,

BACKGROUND

- On 20 February 2022, you approved the public notification of the proposed scheme and consultation on a draft DCOP.
- The CRRDA carried out public notification of the proposed scheme and consultation on the draft DCOP,
 IPBR and Kent Street guideline between 23 February 2022 and 6 April 2022.
- A total of 170 submissions were received, including four late submissions.
- A detailed evaluation of the submissions received, along with an assessment of the merits of the submissions. A record of the extent to which the proposed development scheme was amended to reflect the submissions is contained in the submissions report (Attachment 2) and summarised in the Results of Consultation section of this brief.

KEY ISSUES

The scheme


- The scheme provides for the renewal and repurposing of government land holdings and assets surrounding the Boggo Road CRR Station. It enables development opportunities that leverage public infrastructure in the PDA and accommodates an expansion of knowledge-intensive activities to stimulate growth in innovation and jobs in health, science, and education services.
- Your earlier approval considered the policy content of the proposed scheme and the Results of Consultation section of this brief outlines the matters arising from public notification that may be relevant to your consideration of the approval of the scheme.

The DCOP

- The DCOP sets infrastructure charges for development in the PDA and identifies trunk infrastructure eligible for an offset against the charge. The IBPR supports the application of the DCOP and includes the desired standards of service for the trunk infrastructure.
- The DCOP and IPBR will assist the MEDQ in exercising powers relating to infrastructure contributions matters in the PDA under section 10(1)(f) and section 85 of the ED Act.

The key changes made to the consultation version of the DCOP are summarised below:



Previously, the DCOP allowed a maximum offset of 70 per cent of the cost of each trunk item which
enabled a reserve of funds for emerging infrastructure projects. Further analysis of potential project
delivery indicates this is not required and therefore this has been removed.

Kent Street guideline

- The Kent Street Movement Corridor accommodates vehicular access and servicing requirements for development between the eastern side of the rail line and the western side of the Princess Alexandria Hospital (PAH). It also provides for active transport connections from Dutton Park Station through to the PAH precinct.
- The Kent Street guideline informs the design of the movement corridor.
- A draft guideline was publicly notified by the CRRDA alongside the proposed scheme. Minor changes have been made in response to submissions as outlined in section 6.2 of the submissions report (Attachment 2).

Revocation of delegations to the CRRDA

- With the sequential declaration of the four CRR PDAs, the MEDQ delegated to the CRRDA certain functions and powers of the MEDQ under the ED Act. Broadly, the delegated powers and functions are for:
 - development assessment (DA)
 - development scheme making and amending
 - administering conditions, including infrastructure charging conditions (and associated offsets, credits, refunds), although the CRRDA is not permitted to fix charges
 - entering contracts, infrastructure agreements and other agreements
 - enforcing approval conditions, including associated court proceedings
 - dealing with land or other property
 - acquiring land, developing land, disposing of land or dealing with property held by the MEDQ (e.g., leasing or licensing arrangements)
 - constructing roads, closing roads, stopping traffic for roads
 - keeping registers for certain matters (e.g., PDA development applications and approvals).
- On 23 March 2022, you approved the transition to occur concurrently with the approval of Boggo Road CRR PDA Development Scheme.
- The loDDs provide for the revocation to occur upon the giving of written notice to the delegate. A letter to the Mr Graeme Newton CEO of the CRRDA is included for your signing (Attachment 5).

The revocation of delegations under the ED Act will have no impact on the CRRDA's powers and functions under the Cross River Rail Delivery Authority Act 2016 (CRRDA Act). For example, the CRRDA has broad powers under that Act to deal in land, take land via compulsory acquisition and hold land for its own functions.

RESULTS OF CONSULTATION

- Of the 170 submissions received during the public notification period:
 - 136 were from Brisbane residents
 - 12 were from industry and advocacy groups
 - four were from public sector entities
 - 18 were from residents outside of Brisbane or where no address was provided.
- The submissions report (Attachment 2) provides a detailed summary of the submissions received.
 The key matters are outlined below:

Open space

- The size of the replacement Outlook Park should be increased, and open space should be provided over the rail corridor.
- Due to steep batters around its edges, the original Outlook Park had a useable area of approximately 1,000m². The new permanent Outlook Park will deliver a fully usable area of approximately 2,100m² uplifting the useability of the space.
- The scheme does not preclude the potential for future open space areas over the rail corridor.

Building height

- According to Mr Graeme Newton, CEO, CRRDA in his letter to you seeking endorsement of the scheme (Attachment 9), the Honourable Minister Bailey MP, as Minister for CRR, observed that a maximum building height of eight storeys on the Dutton Park Police Station site may be the subject of local community commentary into the future, but noted that this observation did not preclude advancing the scheme for review and endorsement.
- The Dutton Park Police Station site is 50 metres south of the Dutton Park State School. Given the
 relationship of the site to the school it is considered unlikely that future development on the site will
 significantly impact privacy, amenity or overshadowing.
- The nearest residential dwelling to the Dutton Park Police Station is more than 40 metres away, diagonally
 across Annerley Road (consisting of five lanes of traffic, a bicycle lane and median street). It is considered
 unlikely that development on the site will result in significant privacy and amenity or overshadowing impacts
 for these residents.
- The scheme provides for the redevelopment of the Dutton Park Police Station for non-residential and mixeduse activities with a focus on knowledge, research and innovation activities.
- There is no current plan to redevelop the Dutton Park Police Station. Any future development of the Dutton Park Police Station site will require a PDA development application, where any adverse privacy and amenity impacts to nearby uses will be assessed and appropriately mitigated.

Social and affordable housing:

Some submitters suggested the PDA should only permit residential development that is public housing.
 Others suggested the PDA accommodate social and affordable housing.

The scheme provides for land uses that will reinforce the PDA's role as a globally significant innovation precinct, leveraging the existing agglomeration of health and knowledge uses and the substantial investment in public transport infrastructure. To this end, the scheme does not promote residential development in the PDA.

RESOURCE/FINANCIAL IMPLICATIONS

The CRRDA Planning Team has transitioned to EDQ and is appropriately resourced to administer additional resource requirements arising from the revocation of the delegations to the CRRDA.

Further to your letter of 20 February 2022 confirming your approval to publicly notify the Proposed Development Scheme (PDS) and associated documentation for the Boggo Road Cross River Rail Priority Development Area (PDA), I am pleased to advise that the Cross River Rail Delivery Authority (CRRDA) has completed public notification.

The submission period ran between 23 February 2022 to 6 April 2022 inclusive, with advice inviting submissions published in the Courier Mail on 22 February 2022. For the duration of the submission period, the PDS and supporting documentation were displayed on both the CRRDA's and Economic Development Queensland's (EDQ) websites. Paper copies of the PDS and supporting documentation were also made available at the CRRDA's Experience Centre at 123 Albert Street, Brisbane City.

The CRRDA received a total of 170 submissions, including 4 late submissions, about the PDS and associated documentation. Copies of the submissions have already been sent to EDQ officers for your records. The submissions have been considered and are summarised in the Draft Submissions Report, which is enclosed together with the following for your review and endorsement:

- Development Scheme Boggo Road Cross River Rail Priority Development Area (Development Scheme)
- Kent Street Movement Corridor Guideline Boggo Road Cross River Rail Priority Development Area (Guideline)
- Development Charges and Offset Plan Boggo Road Cross River Rail Priority Development Area (DCOP)
- Infrastructure Background Report Boggo Road Cross River Rail Priority Development Area (IBPR).

The amendments made to the Development Scheme, Guideline and DCOP are considered warranted, responding to matters raised by submissions. The amendments are not considered significant changes and I confirm my intention not to re-notify.

The Minister for Transport and Main Roads and Minister responsible for Cross River Rail has been briefed regarding the Development Scheme.

The Minister was supportive of the Development Scheme, however observed that building heights of potential future development of the Dutton Park police station site may be the subject of local community commentary into the future. The Minister noted that this observation did not preclude advancing the Development Scheme to EDQ for review and endorsement.

Subject to your endorsement of the Development Scheme and associated documentation, the CRRDA together with EDQ will undertake the necessary steps to ensure the Development Scheme, Guideline and DCOP take effect in a timely manner before expiration of the PDA's Interim Land Use Plan in November 2022.

Throughout the PDA declaration and Development Scheme drafting processes, the level of collaboration between EDQ and the CRRDA has been high. I appreciate how our officers have worked constructively together and look forward to this continuing.
